Any vote which is not filled or filled wrongly or with unrecognizable writing or not cast will be counted as "abstained". If you do not indicate how you wish your proxy to vote, your proxy will be entitled to exercise at his/her discretion. Unless you have indicated otherwise in this form of proxy, your proxy will also be entitled to vote at his/her discretion on any other resolution duly put to the Class Meeting of H Shareholders other than those referred to in the notice of the Class Meeting of H Shareholders.
- 6. This form of proxy must be signed by you or your attorney duly authorized in writing or, in the case of a legal person, must either be executed under seal of the legal person or under the hand of a director thereof or an attorney duly authorized to sign the same. In case of joint holders of the Shares, this form of proxy must be signed by the joint holder whose name stands first in the register of members of the Company.
- 7. To be valid, this form of proxy, together with a notarially certified copy of the power of attorney or other authorization documents if it is signed by a person on behalf of the appointor, must be delivered to the Company's H share registrar, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong (for the purpose of H Shareholders of the Company) not less than 24 hours before the time for holding the Class Meeting of H Shareholders or the time appointed for voting by poll (i.e. at 2:30 p.m. on Monday, July 28, 2025).
- 8. Where there are joint holders of any H Shares, any one of such persons may vote at the Class Meeting of H Shareholders, either personally or by proxy, in respect of such H Shares as if he/she were solely entitled thereto. However, if more than one of such joint holders are present at the Class Meeting of H Shareholders, either personally or by proxy, then one of the said persons so present whose name stands first in the register of members in respect of such H Shares shall alone be entitled to vote in respect thereof. A proxy need not be a Shareholder. In the event that a shareholder appoints more than one proxy to attend the Class Meeting of H Shareholders, such proxies may only exercise their voting rights in a poll.
- 9. Please note that completion and return of the form of proxy will not preclude the Shareholders from attending and voting in person at the Class Meeting of H Shareholders or any adjournment thereof if they so wish.
